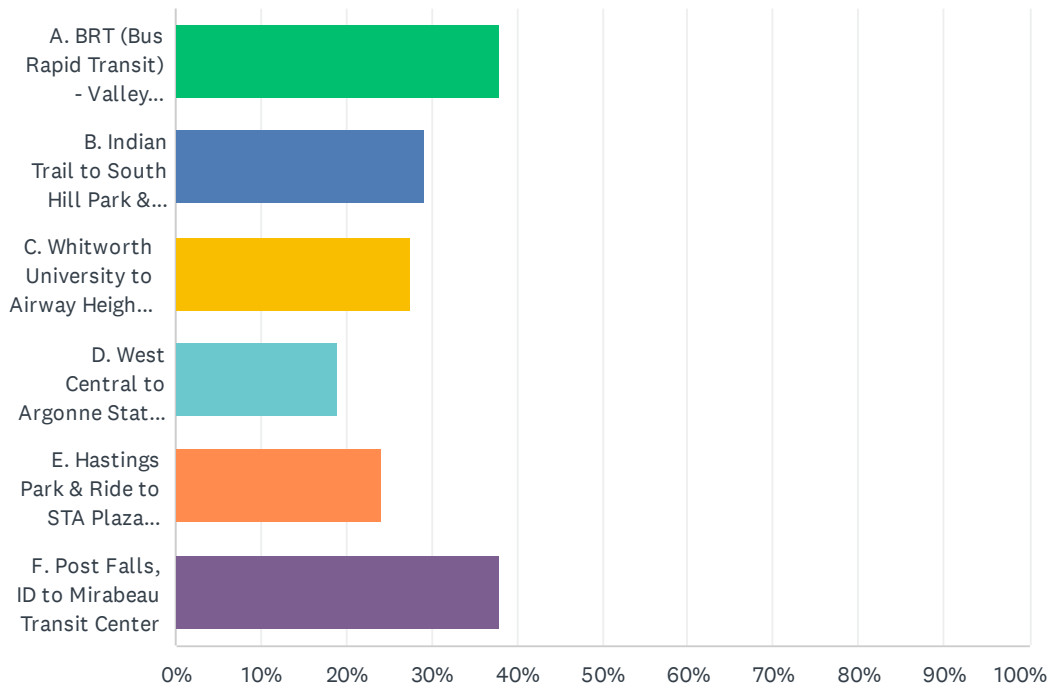

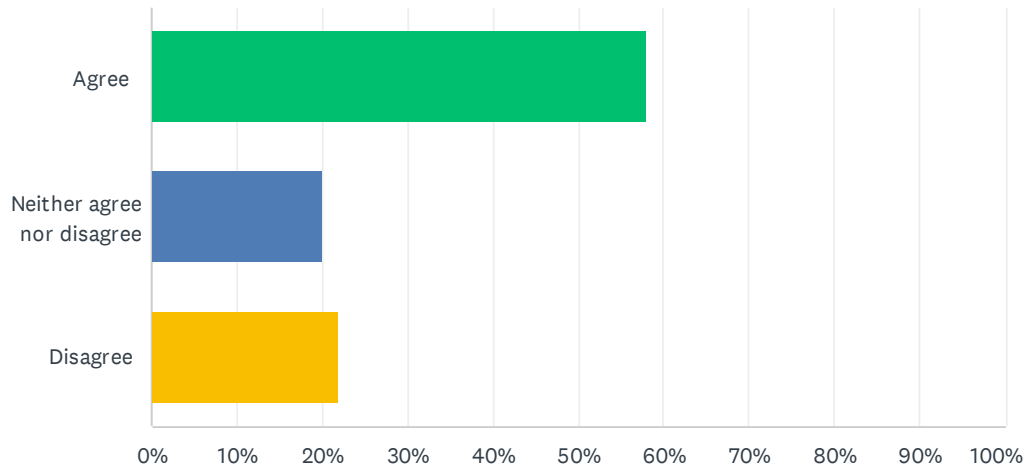

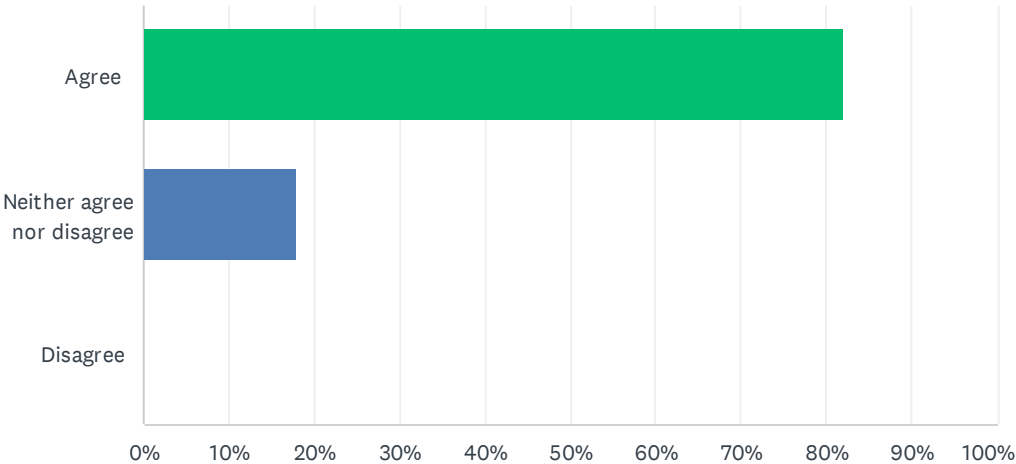

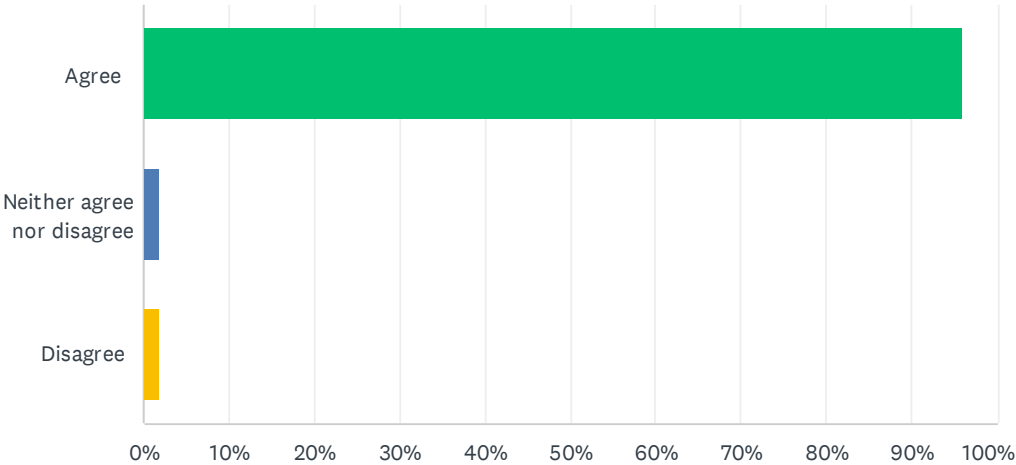

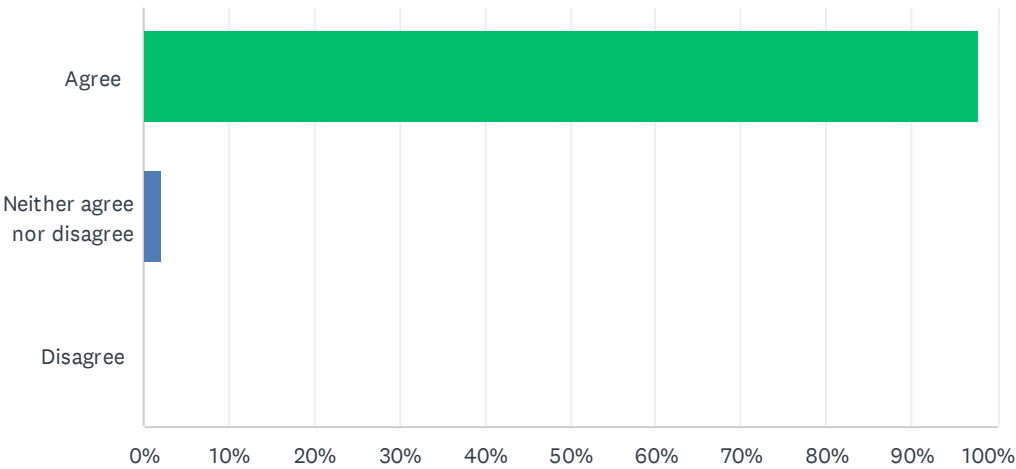

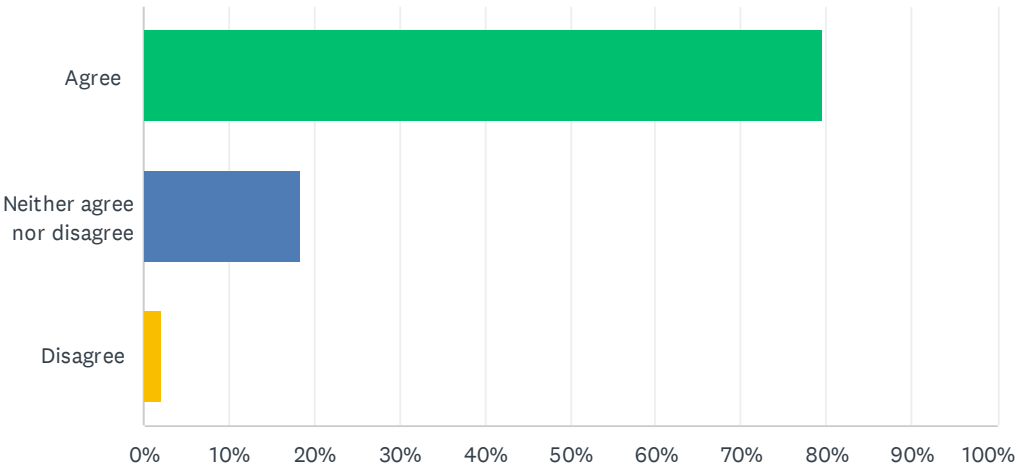

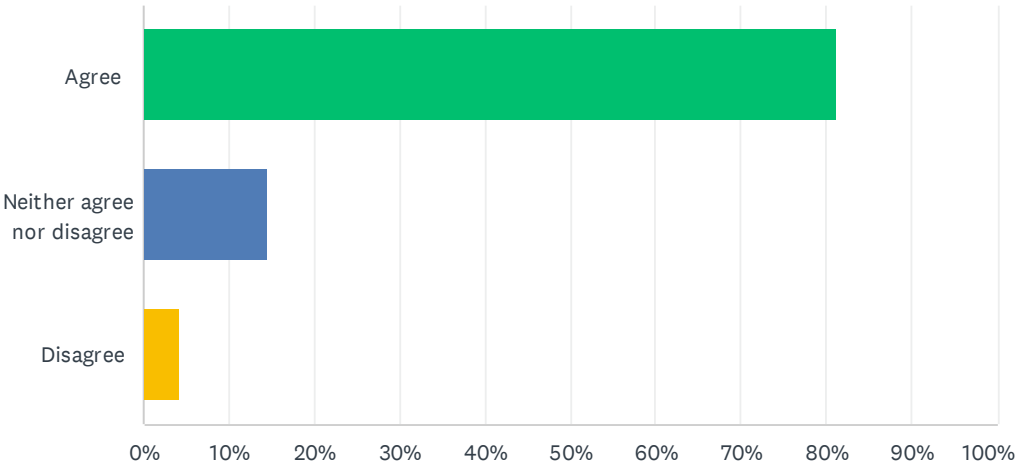

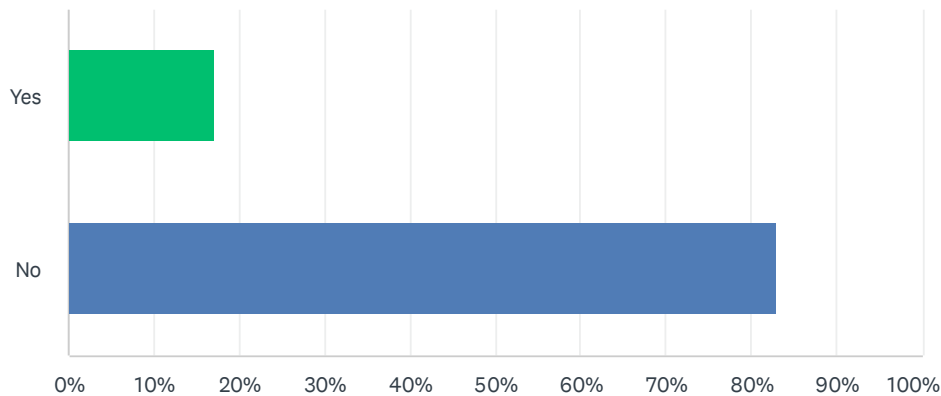

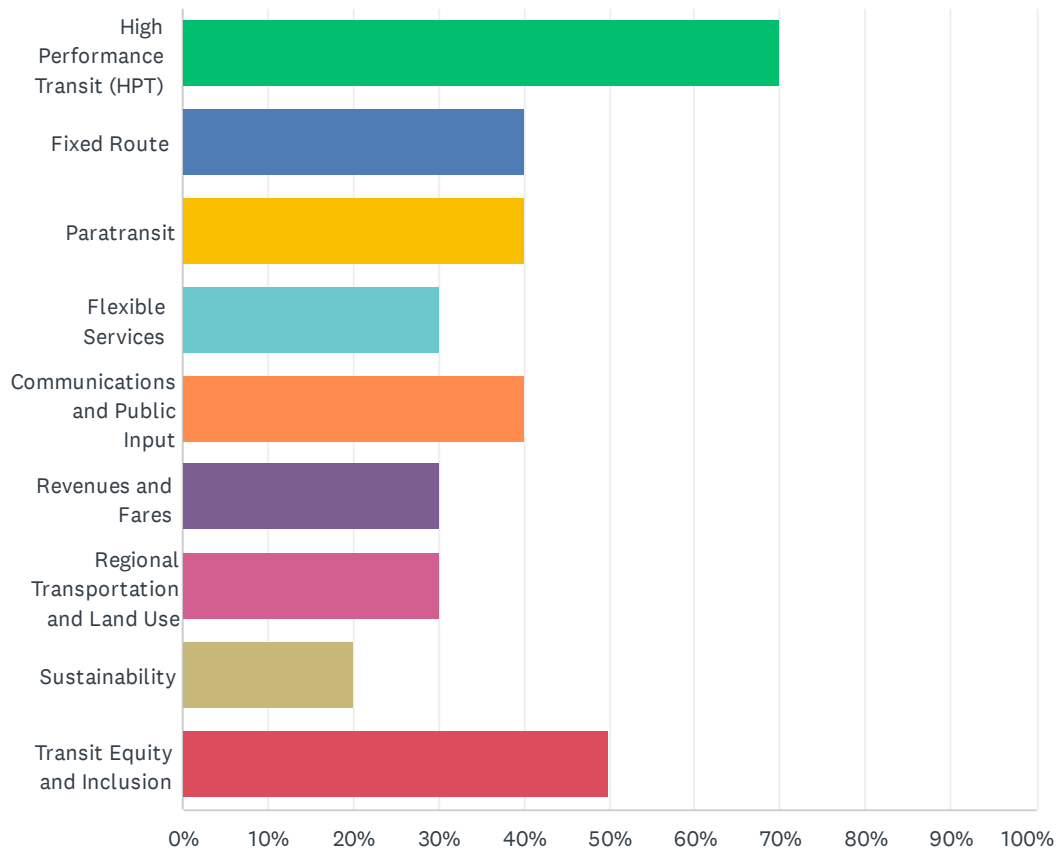

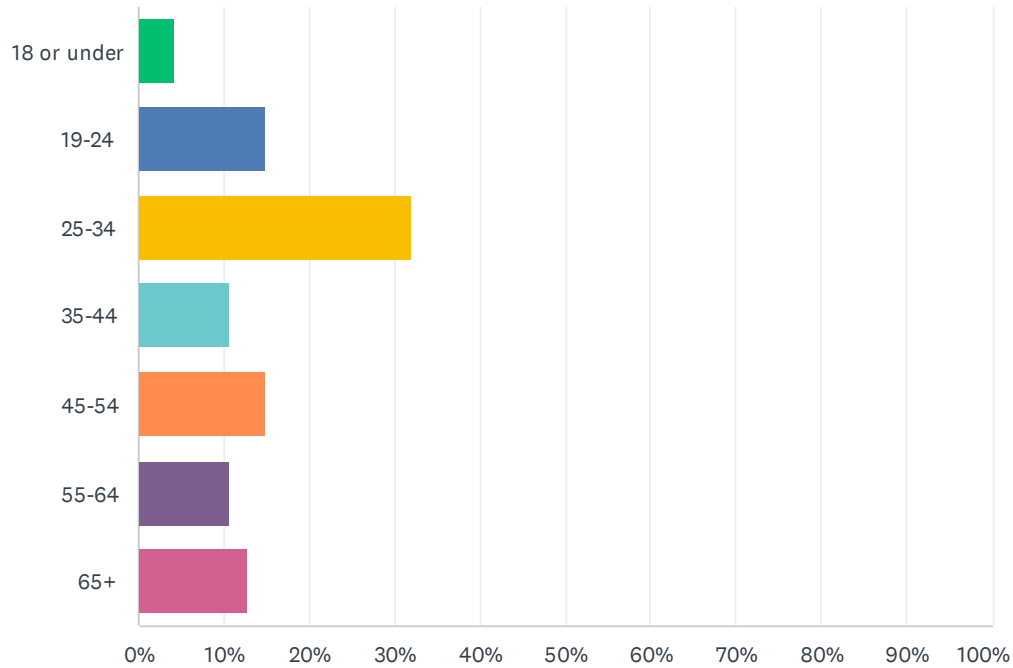

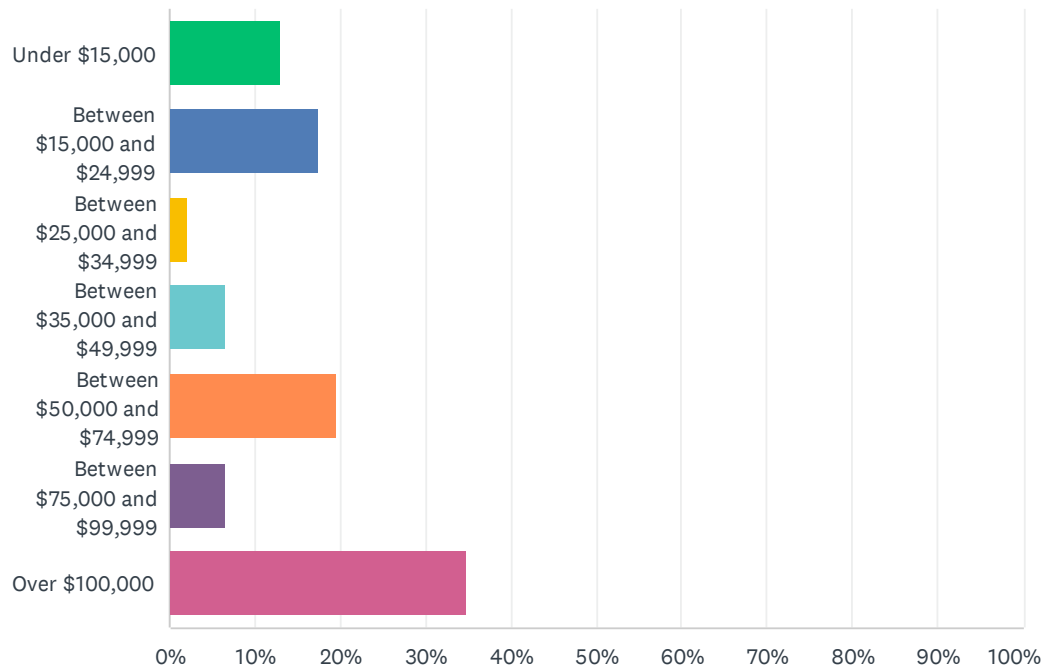

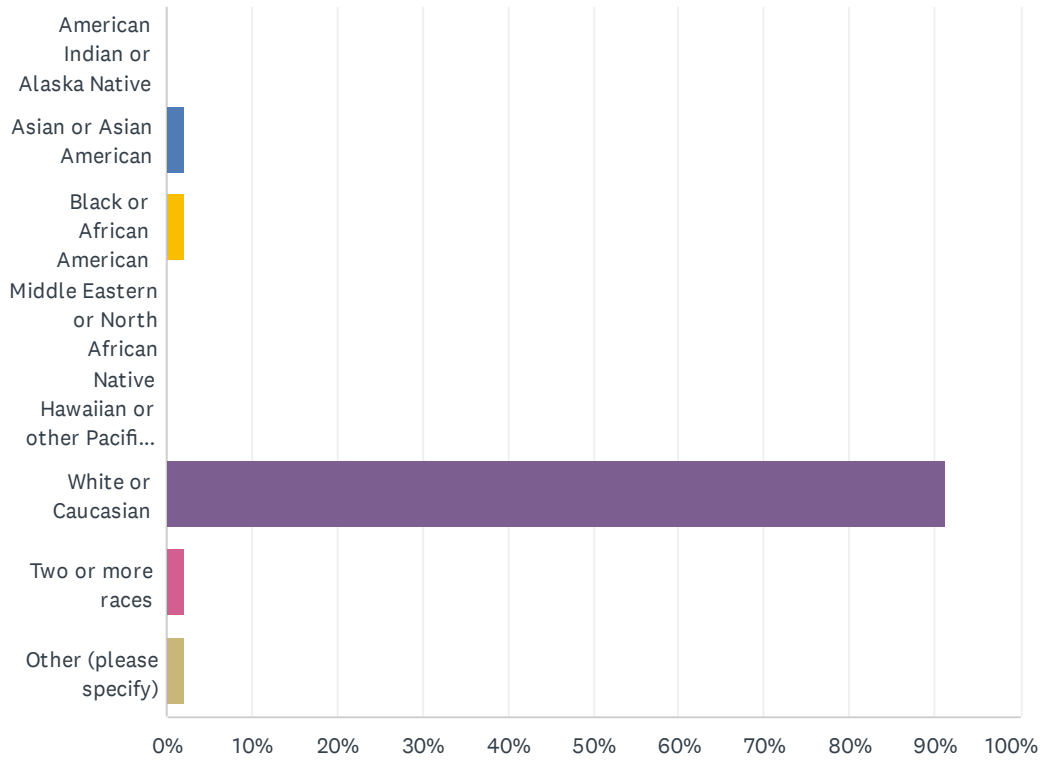

Q24 How do you self-identify by race?

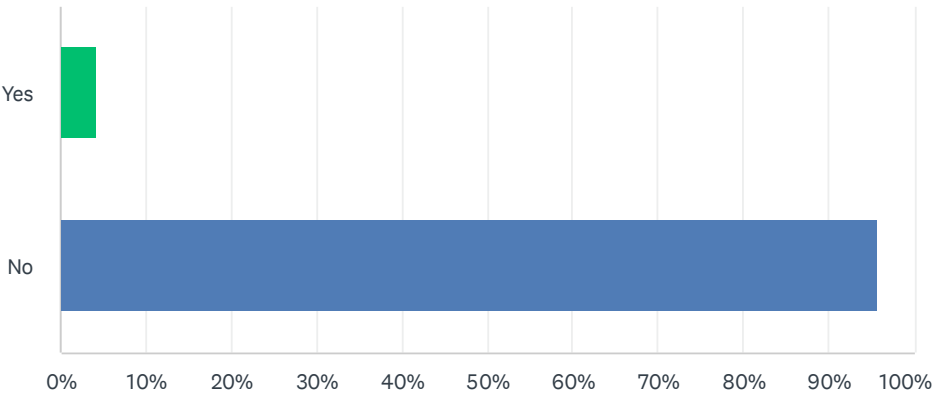

Q25 Do you identify as Hispanic or Latino?

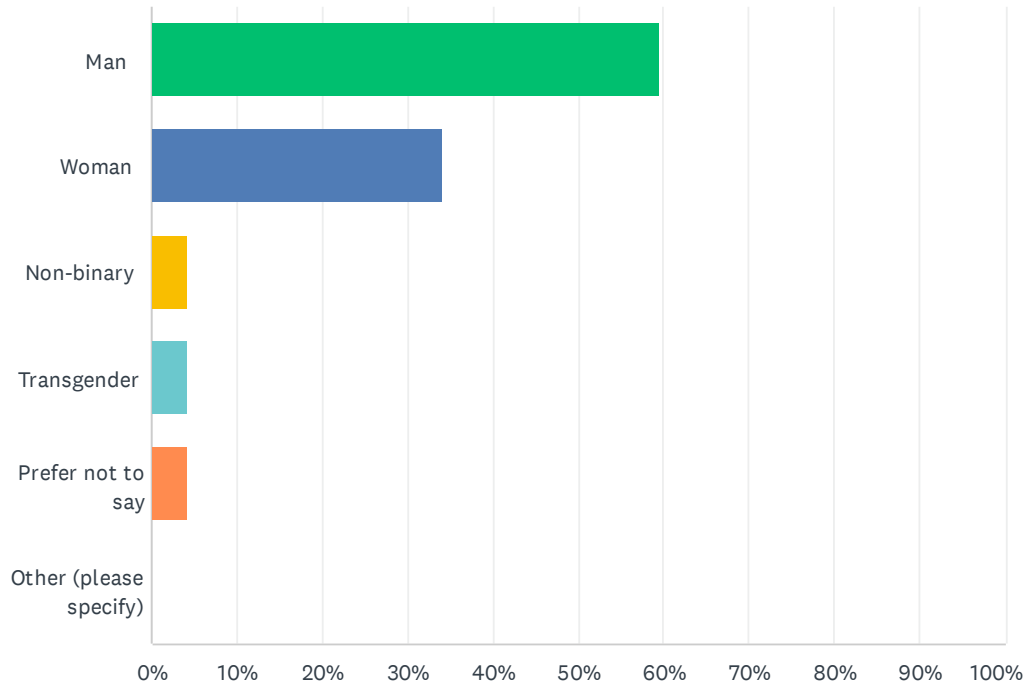
